2. Wrap up of the 2010 Championships

- a. Concerns

Judy Flinn reported that Bill Bowman, Referee for the ski events, suggested that the last gate in a combination in single pole slalom be offset to aid the racer in reading the course.

Todd Kelly, TD for the Championships, suggested that correct snowboard stubbies be used at the Championships.

Lucy Schram suggested that a "team" course set be used at the Championships in order to be sure that all course specifications are met.

Ski/Snowboard/Nordic Dues - \$ 225/team
Championship Fee - \$ 200/school

8. Coach Certification Reminders
 - a. Bill Treat reminded all coaches that any person working with a team must have been certified.
 - b. CIF updates the certified coach list every month.
 - c. November 15, 2010 he will need from each school a list of certified coaches to check against the master list. He needs the date of certification and the city in order to quickly check against the master.

Reminders about Volunteer or Privately Paid Coaches

CNISSF coaches must screen all volunteer/privately paid coaches and verify that these individuals meet all the criteria for coaching in their school district. This includes but is not limited to fingerprinting, possession of a valid First Aide Card, CPR Certification, and all other district requirements. Please verify with your athletic director that all "coaches" have met the school district requirements before working with your team. It is recommended that all coaches be approved by the school board to transfer the liability to the school district.

SNOWBOARD stubbies will be used in all snowboard championship events.
12. Change to Championship Guidelines (Ski Area Responsibilities, Page 10/19) and Bylaws (Championship Meets - Alpine, Page 10/18.)

A "team" set is required for all Championship courses.
(One member of the "team" sets the course and the other member of "team" verifies that the setter is meeting all course requirements such as red/blue, delays, flushes and combinations in slalom, distance and gate count for the hill percentage)

13. Change to Championship Guidelines (Run Order, Page 11/4) and Bylaws (Championship Meets-Alpine, Page 10/19)

The school year of the racer will be listed on the start list(s) and race results in the format 9, 10, 11, 12.

14. Modification of the CNISSF Constitution (Page 2/12)

"Prior to each interscholastic season, each participating school must forward a list of eligible students to the schools in its division. This list must be signed by the principal or his designated representative." was **DELETED** from the Constitution.

Delete: "The Chairperson will send an annual report to the principal of each high school after the April or May meeting each year."

Replace with: "Coaches will direct high school officials to the CNISSF website for information about CNISSF."
